**NOTICE** is hereby given that the Naples City Council will consider enactment of the following Ordinances upon Second Reading at the Regular City Council meeting to be held on **Wednesday, September 16, 2026, at 8:30 a.m.**, or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

**AN ORDINANCE AMENDING SECTION 22-37(15), LEAF BLOWERS, OF ARTICLE II, NUISANCES, OF CHAPTER 22, ENVIRONMENT, OF THE CODE OF ORDINANCES, CITY OF NAPLES, FLORIDA TO COMPLY WITH CHAPTER 2026-3, LAWS OF FLORIDA; AND PROVIDING FOR CODIFICATION, CONFLICTS, SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS, CONSTRUCTION, PUBLICATION, AND AN EFFECTIVE DATE.**

**AN ORDINANCE AMENDING SECTION 2-51 – REGULAR MEETINGS; AMENDING PARAGRAPH (a) OF SECTION 2-54 – QUORUM; ABSENTEES; PUBLIC MEETINGS, OF DIVISION 2 - MEETINGS, OF CHAPTER 2 – ADMINISTRATION, OF THE CODE OF ORDINANCES, CITY OF NAPLES FOR THE PURPOSE OF ALLOWING FLEXIBILITY FOR ADDING ADDITIONAL REGULAR MEETINGS OF CITY COUNCIL AND ADDRESSING ATTENDANCE PROVISIONS THROUGH THE CITY COUNCIL'S RULES OF PROCEDURE; PROVIDING FOR CODIFICATION; CONFLICTS; SEVERABILITY; CORRECTION OF SCRIVENER'S ERROR; CONSTRUCTION; PUBLICATION AND AN EFFECTIVE DATE.**

All people are invited to appear and be heard with respect to said proposed ordinances.
